

Privacy policy

This privacy policy sets out how Equipment Trading International BV ("ETI") uses and protects any information that you may provide to us using our website and/or our services. We may change this policy from time to time by updating this page. This policy is effective from June 21, 2018.

PERSONAL DATA THAT WE PROCESS

ETI may processes your personal data due to your use of our services. "Personal data" is any data concerning an identified or identifiable natural person as is meant in the General Data Protection Regulation ("GDPR"). The personal data we process is mainly contact information. These are the contact details that you may provide to use the services of ETI, such as your name and/or (company)email address and other personal data that you may actively provide by, for example, by requesting our services.

FOR WHAT PURPOSE AND ON WHAT BASIS WE PROCESS PERSONAL DATA

ETI will only provide personal data to third parties if this is necessary for the execution of our agreement with you or your company or to comply with a legal obligation. With companies that process personal data in our assignment, we conclude a processor agreement to ensure the same level of security and confidentiality that we offer.

COOKIES, OR SIMILAR TECHNIQUES, THAT WE USE

A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone when you first visit this website. ETI only uses anonymized analytical cookies which cannot be tracked back to you personally as a visitor of our website. The cookies just give an overall insight on how people browse our website. You can opt out of cookies by setting your internet browser so that it does not store cookies anymore. In addition, you can also delete all information previously saved via the settings of your browser.

VIEW, MODIFY OR DELETE DATA

You have the right to view, correct or delete your personal data. In addition, you have the right to object to the processing of your personal data by ETI. You can send a request for access, correction, deletion, or objection to the processing of your personal data to sales@e-t-i.nl. To protect your privacy and to ensure that the request has been made by you, we may ask you for identification. We will respond to your request as quickly as possible, but ultimately within four weeks.
